

HCBS Child Medicaid Waiver Requirements

Children's Extensive Support Waiver (CES)

- Ages: birth - 17 years
- Children determined to have a developmental disability or delay that are most in need due to the severity of their disability (with additional targeted criteria)
- Children with intensive daytime and nighttime behavioral or medical needs who are at risk of institutionalization
- Children, birth - age 5, must have a medical diagnosis of developmental delay
- Children, age 5 - 17, must have a medical diagnosis of developmental disability
- Countable assets in the child's name cannot exceed 300% of the current maximum SSI standard monthly maintenance allowance

Children's Habilitation Residential Program Waiver (CHRP)

- Ages: birth - 20 years
- Children who have an intellectual or developmental disability or developmental delay if under age five (5), or a serious emotional disturbance **and** have intensive behavioral or medical support needs that put them at risk or in need of out-of-home placement
- Waiver services help children and youth learn and maintain the skills needed to live in their communities
- Countable assets in the child's name cannot exceed 300% of the current maximum SSI standard monthly maintenance allowance

Children with Complex Health Needs Waiver (CwCHN)

- Ages: birth - 19 years
- Children with a life limiting illness diagnosis who can be safely cared for in the home and who are at risk of institutionalization in a hospital Or;
- Children who are/have:
 - + Technologically dependent for life or health sustaining functions, Or;
 - + Complex medication regimen or medical interventions to maintain or improve health status, Or;
 - + Need of ongoing assessment or intervention to prevent serious deterioration of health status or medical complications that place life, health, or development at risk
- The general purpose of this waiver is to primarily help children with complex medical needs
- Countable assets in the child's name cannot exceed 300% of the current maximum SSI standard monthly maintenance allowance
